BOARDING CONTRACT

This is a Contract between Pawprints Kennels & Cattery and the pet Owner.

Pawprints agrees to exercise due and reasonable care, and to keep the kennel premises sanitary and properly enclosed.

Your pet(s) is to be fed properly and regularly, and to be housed in clean, safe quarters.

All pet(s) are boarded, handled and cared for by Pawprints without liability on Pawprints part for loss or damage from disease, theft, fire, death, running away, injury, or harm to persons, other pet(s), or property by said pet(s), or other unavoidable causes, due diligence and care having been exercised.

Owner agrees to pay to Pawprints daily rate per pet(s) per day for boarding service. Owner understands and agrees that pet(s) picked up by Owner after 10.00am shall be charged for an additional full days stay.

All charges incurred by the Owner shall be payable upon pick-up of pet(s) or as arranged between the owner and Pawprints.

Payment Methods: Cash / Cheque / Internet Banking (no later than day of collection) We do not have Eftpos

Owner further agrees that pet(s) shall not leave Pawprints until all charges are paid to Pawprints by the Owner unless otherwise arranged. We reserve the right to charge interest at 2.5% per month and to charge a late payment penalty of 10%/0 on any overdue accounts. If the account is not paid within 30 days after the due date, our debt recovery agency may charge you a fee equal to 25% of the unpaid portion of the price, but not less than \$25.00. Where the total agency, legal and other costs arising from recovery of any amount owing exceeds the debt recovery fee charged, our agent is also entitled to recover such additional costs from you. This clause is intended to be for the benefit of and be enforceable by our debt recovery agency under the contracts (Privacy) Act 1982.

Pawprints shall have, and is hereby granted, a lien on the Pet(s) for any and all unpaid charges resulting from boarding pet(s) at Pawprints.

If the pet(s) becomes ill or if the state of the animals health otherwise requires professional attention, Pawprints, in its sole discretion, may engage the services of a veterinarian of its choosing, administer medicine or give other requisite attention to the animal, and expenses thereof shall be paid by the Owner.

It is understood by Pawprints and the Owner that all provisions of this Contract shall be binding upon both parties thereunto for this visit and for all subsequent visits. This Contract contains the entire agreement between the parties.
